You will develop and improve and facilitate contractor safety programs for the Cambridge site. You will develop the framework for the management of potential risks to human health and/or the environment resulting from activities involving facility maintenance operations.
About the Role
Key responsibilities:
Facility Health & Safety Programs:

- Facilitate safety compliance programs such as confined space entry, lockout/tag out, hot work and fall protection, electrical safety and job hazard analysis programs that are appropriate in consideration of the site's complexity, population, regulatory burden/environment, criticality and location.
- In collaboration with project managers, leads commissioning safety programs associated with design and construction management activities at the site. This may involve daily management of contract resources.
- Develops and leads implementation of safety critical preventative maintenance and inspection programs.
- Builds, implements, and provides long term management to facility self-inspection programs.

## Project / Contractor Safety:

- Develops and maintains site contractor safety program, including prequalification and training processes.
- Conducts HSE management for capital project reviews, including new facility assessments and decommissioning activities.
- Participation hazardous operations safety assessments for facility and scientific operations.

# Fire/Life Safety

- Provides technical expertise and oversight for facility fire protection systems and code compliance programs, including management of consultants.
- Leads Collaborate with FM Global and provides management of recommendation & implementation action plans.

## Role Requirements:

### Experience:-

- 1-3 years of relevant HSE program experience, preferably with knowledge and experience with facilities-based safety programs and contractor safety programs
- A solid understanding of pharma industry and the nuances of pharma HSE issues is a plus.
- Highly motivated self-starter with a proven track record to assume accountability & responsibility, take ownership for their work, and intelligently challenge the status quo.
- Competency in analytical and problem-solving skills.
- Strong leadership, influencing and communication skills.
