- Deliver actionable insights through behavioral research using mixed methods (e.g. survey design, user experience testing etc.) and perform data analysis using statistical software (e.g. R) to measure impact.

- Support senior stakeholders in understanding behavioral insights and actioning on practical insights.

- Stay abreast of industry trends, model practices, and emerging research in behavioral science, ethics, and organizational culture, and share insights and recommendations with internal partners.
