- Ownership of the site Validation Master Plan (VMP) (creation and maintenance).
- Ensure all manufacturing, packaging and cleaning processes are validated and ongoing verification is implemented, so that all site products are validated and remain in constant state of validation throughout the product lifecycle.
- Accountable for technical transfer activities into, within and out of the site, and ensure appropriate increase in production with aim to commercialize scale-up of new products.
- Ensure the site has set and rigorously applies appropriate technical standards for processing, packaging and materials, where applicable, employing new/modern processes and technologies (e.g. Quality by design-QbD, planning experiments, process analytics technology PAT).
- Other tasks determined during the objectives setting process and by KPIs.

- MSc. in Science, Pharmacy or Chemical Engineering, Pharmaceutical Technology or equivalent experience. Ph.D. desirable.
- Functional knowledge of English.
