- As part of the submission and implementation strategy drive the agreement on the change request strategy and ensure that the project related change requests in the corresponding change control system are maintained in an adequate status as required by the processes.
- Define and establish the master data strategy during initiation phase together with MDG / LCI to ensure an early master data modelling for all Life Cycle Projects.

- Minimum 3 years of experience, including at least 2 years experience in various pharmaceutical functions e.g. supply chain / production and / or technical development.
