- Expert in Warehouse and Logistics, ensures adherence to operational discipline and GMP/HSE within these sectors.
- Identifies gaps, ensuring performance, quality, and budget adherence, and leads process improvement initiatives when necessary.
- Owns all systems and equipment as delineated in the Validation Master Plan.
- Supports major events and audits, ensuring appropriate corrective and preventive actions are taken.

- Over 4 years of experience in logistics, preferably in a GxP or Pharma environment.
- Experience with dangerous goods shipments and managing 3rd party warehouse and logistics providers.
- Knowledge in radiopharmaceutical field is desirable, with experience in radioactive sources logistics.

- Fluency in both Italian and English.
- Demonstrates technical knowledge in supply chain.
- Professional experience within the pharmaceutical industry or a regulated environment.
